Executive Summary

The Coastal Discovery Museum is a mainstay for tourists visiting Hilton Head Island. Our 68-acre historic property and museum are open for visitors to enjoy free of charge, and we offer year-round programming for all ages. We often hear from our tourists that a vacation on Hilton Head isn't complete without a trip to the Coastal Discovery Museum. We hosted our first visitors at Honey Horn in 2007 and have steadily grown our programs to become a vital part of the island's recreation, leisure, and educational economy. Since then we have reached over 1.49 million patrons, including over 1 million tourists. ATAX grant support is a significant part of this success. It has allowed us to continue operating in difficult times, including while we served as a FEMA debris management site after Hurricane Matthew and while we figured out how to operate in a COVID-19 world.

The Coastal Discovery Museum has an important mission – to inspire people to care for the Lowcountry – but we also strive to be a business that operates ethically, sustainably, and efficiently. ATAX funding provides approximately 20% of the museum's operating budget and without it our marketing efforts, programming, and facilities would not be performing at the level required to maximize our benefit to the tourism economy and the local community. We know that ATAX funding is limited and we are careful to be responsible stewards of this grant. Over the fiscal years 2017-2021 we kept our ATAX spending per patron under \$3.00. In FY21, we exceeded our goal, spending \$4.65 per visitor. We proposed in our last ATAX application that we would reduce that to under \$3 per patron. This year we are

proud to report ATAX spending was \$2.02 per patron, or \$2.80 per tourist. Coastal Discovery Museum is one of only seven organizations on the island which have earned a platinum level of transparency from Guidestar, the lead organization reporting on nonprofits.

In FY 2022, our successful marketing plan, included our online presence drove 35% of our attendance, referrals from locals driving 25% of our attendance, and our seasonal calendars and other print and TV driving 26% of our attendance.

We introduced new programs, including two new pre-K programs for visiting families and evening art and environment programming for adults. We continued our Farmers' Market on Tuesdays and it has grown to serve 500-600 people per day.

We increased our print marketing and reduced our online offerings post pandemic and in the spring saw numbers that were on par with those we had prior to the pandemic. We will remain responsive to changing parameters, but we anticipate more normal tourism in the coming year, and the continuation of a more normal marketing program. Some of our pandemic programming, particularly small group hands-on experiences performed very strongly and we will continue these. One of the pleasant surprises we had from the pandemic was an increase in our online educational programs from out-of-state schools. Many of our summer tourists mentioned our programs to their schools or home-school groups and we were able to continue to do educational programs for them this year. We hope that we are training the next generation of tourists who will love our island to also care for our fragile environment and fascinating history, and it is great to be more connected to these tourists year-round.

We are working every day to find ways to improve the level of service we give to our visitors so that we don't lose customers to our business or quality tourists coming to Hilton Head Island. We are proud that in FY 2022 we were able to reach 125,645 patrons in person and 116,104 tourists for a 92.3% tourism ratio. These numbers are nearly double our attendance last year. ATAX funding has allowed us to market and maintain the Town of Hilton Head Island's Honey Horn property as an active and vibrant destination for visitors and residents to enjoy. This success is reflected by our high positive ratings in a number of online and print sources, including: 101 Things to do on Hilton Head Island (#1); U.S. News, Best things to do on Hilton Head; Travel and Leisure's place to "Learn About, Meet, and Adopt the Wildlife"; USA Today's Hilton Head's 10 Best Attractions (#6). On TripAdvisor, the Coastal Discovery Museum is the top thing to do on Hilton Head Island after Coligny Beach and our bike trials.

Provide a brief summary on the intended use of the grant and how the money would be used. (100 words or less)

Coastal Discovery Museum uses ATAX funding to drive tourism and improve visitors' experiences on HHI. We promote nature, history, and arts programs in alignment with Hilton Head as a family friendly destination. We market online, through social media, in print, and on-air. ATAX grants fund marketing efforts, new in-person and online museum experiences, free admission to the museum and grounds, live animal

programs, and the promotion of the Santa Elena story which is featured in 4th and 8th grade school textbooks. Continued funding ensures we remain a top island attraction and one the three highest rated museums in SC.

How does the organization/event either drive tourism to Hilton Head Island or enhance the visitor experience on Hilton Head Island? How is this impact being measured? (100 words or less)

This year we reached 125,654 individuals in person and 2092 virtually. Most virtual programs were for school groups. The majority of our attendance remains tourist-driven, comprising 92.4% of our total attendance. Approximately 4.2% of our additional attendance is Hilton Head residents and 3.3% from Bluffton. The CDM is a leading driver of heritage tourism to the island and works with cultural partners and the Chamber to showcase the diversity of tourist experiences on island and promote it to potential visitors outside our area. Our call center and front desk help direct tourists to other venues and services across the island.

A. Total Number of Physical Tourists Served: 116,104

A Tourist is considered a non-resident, traveling more than 50 miles to the Town of Hilton Head Island.

How was the Number of Visitors/Tourists Documented? (250 words or less)

In FY2021 we analyzed a sample of 41,642 zip codes from our tours and check-ins. Our land tours (94% tourists) and our waterway tours (91% tourists) had the highest tourism percentages. Our Discovery Lectures conducted in the fall and spring had the lowest percentage (36% tourists). Overall, entry to the Discovery House averaged 92.4% tourist, we believe this percentage is high because many locals enjoy our property, but don't enter the museum so they aren't counted in our total attendance. This summer we brought back our Coastal Critters program after a two-year hiatus and had 82% tourists. It is unusual to see an increase in then number of local participants in this program, so some locals clearly missed it and came back this year!

In order to determine our total number of visitors/tourists, we apply our percentages calculated for each program category to our total counts of participants. For example, our total number for attendance in the Discovery House based on manual counts of people entering our front door was 68,395 patrons. Based on a sample of 41,642 visitors' zip code data, 92.4% were tourists, 3.3% were visitors, and 4.2% were locals, giving us a total of 38,494 tourists, 1,389 visitors, and 1,759 locals for this program category. Similar numbers were then calculated for each program category and an overall tourism percentage of 92.3% was calculated.

B. DESCRIPTION OF OPERATIONS:

1. For state reporting purposes, give a brief description of the organization. (250 words or less)

Founded in 1985, the mission of the Coastal Discovery Museum is to inspire people to care for the Lowcountry. We do so by teaching visitors about our fragile environment, fascinating history, complex culture, and by encouraging them to take an active role as stewards

of these resources. Beginning in 2007 when we opened at Honey Horn, a Town of Hilton Head Island property, we became more than just a museum. We have permanent exhibits and a constantly changing temporary gallery, but also feature 68 acres of natural beauty, including HHI's oldest buildings, ancient trees, open fields, and boardwalks extending into the marsh. CDM has become a favorite location for cultural festivals, weddings, special events, and our Farmers' Market. Visitors are inspired to learn about Hilton Head Island, participate in nature or history walks, talks, and site-specific programs along the boardwalks or in the Butterfly Enclosure. Guests can tour the Heritage Garden, the Camellia Garden, a replica shell ring, and visit our Marsh Tacky horse in residence. For the past fifteen years, the Museum has enhanced and expanded its offerings of Cultural and Eco-Tourism programs: Lowcountry Critters, walks, talks, tours, workshops, temporary exhibitions, family fun day, horseshoe and blue crab programs, dolphin tours, excursions to Daufuskie and Pinckney Islands, marine life presentations, birding, butterfly workshops, Gullah demonstrations, Civil War programs, sweet grass basket-making classes, loggerhead sea turtle presentations and beach walks. All programs take place on HHI and surrounding waterways with many programs at historic Honey Horn.

2. Describe in detail how the requested grant funding would be used? (250 words or less)

We have returned to ATAX spending on printed calendars and hand-out materials, as well as our website, digital assets, print and broadcast media. Our social media marketing for the museum and Farmers Market are highly successful and we will continue these ATAX funded efforts. ATAX funding allows us to be nimble in promoting our programs, utilizing our Smithsonian affiliation, and launching new programs. This year we will continue to do significant website upgrades, including professionally produced video content about what makes Hilton Head Island so special. We will continue our new exhibit program designed specifically to appeal to art

enthusiasts and nature lovers who may be thinking about visiting, and we are constantly adding new tours like the "Director's Tour".

This integrated model of improved marketing, compelling programs and great exhibitions continues to make Coastal Discovery Museum at Historic Honey Horn one of the leading organizations driving tourism on Hilton Head. Funding at the level requested should lead to an annual 10% increase in attendance and the development and implementation of new programs focused on driving tourism and enriching the visitor experience on the island.

The 2023 ATAX grant request (\$325,000), will be used to underwrite the Cultural and Ecotourism Program budget (\$1,255,000). Other lines of funding include: participation fees (\$150,000); corporate grants (\$100,000); property rental (\$100,000); and individual donations and earned revenue (\$580,000). These funding lines have been awarded/booked for the 2023 year or are in range of previous years. ATAX funding keeps the museum open to tourists free of charge.

3. What impact would partial funding have on the activities, if full funding were not received? What would the organization change to account for partial funding? *(100 words or less)*

The museum reduced our budget during COVID (by \$400k in FY20 and \$300k in FY21). In FY22 we budgeted on FY19 numbers. We ran a deficit in the fall of FY22 but made up for it in the spring and finished the year with a balanced budget. We increased our core staff and continued to fulfill our mission and serve our community. With full funding we anticipate dramatically improving our exhibition program and increasing the number of hands-on programs that we offer for families. With outside grants, we can do this with the same ATAX funding we received last year.

4. What is expected economic impact and benefit to the Island's tourism?
 (100 words or less)

Serving 116,104 visitors from outside a 50-mile radius, the Museum is a leading cultural tourism organization on the island. The museum enhances the visitor experience through our diverse programs and works to connect to potential island visitors through our online and in-print marketing. Typically more than 12% of our website viewers are also looking at travel, hotels, and accommodations and our family-friendly offerings help influence their vacation decision. As a venue for 39 weddings and public events, we further drive tourism and overnight hotel stays on Hilton Head. Our organization and visitors, contribute an estimated \$5,767,252 to the local economy.

6. If not covered elsewhere in the application, please describe (a) how the organization will collaborate with other organizations to enhance tourism efforts, and (b) provide a venue or service not otherwise available to visitors to the Town of Hilton Head Island. (250 words or less)

The museum serves as a center for informing residents and visitors about the rich history and environmental diversity of the island, while also acting as a hub to connect people to other organizations in the region. We are a location for the start of Gullah Heritage Tours, Hilton Head Island History Tours, and Segway tours. We sell tours through Outside Hilton Head and other ecotourism vendors. The Museum runs a Family Fun Day that involves organizations across the Lowcountry, including the Pat Conroy Literary Center, the Outside Foundation, the Gullah Museum, Sandbox, Mitchelville, Heritage Library, Office of Cultural Affairs, HHI Audubon, Archaeological Society and others.

We operate a weekly farmers' market, an annual arts and crafts festival, and serve as the venue for many of the islands popular cultural events including the Lion's Club Chili Cookoff, NIBCA's Gullah Celebration, the Carmines Foundation's Seafood Festival, the Italian Festival and many more. We collaborate with the USCB Marine Biology Research Lab, USCB Center for the Arts, Crescendo, and actively participate in other arts, culture, environment, and history events.

We have created a formal organization, the Historic Sites Collaborative which includes Coastal Discovery, Gullah Museum, Heritage Library, Land Trust and Mitchelville. We are committed to collaboration and will explore joint marketing opportunities including: rack cards representing all five organizations, physical sharing of

marketing materials at our organizations, and new opportunities to drive multiple site visits (for example, QR codes at eight history locations that take people on a 'hunt' to visit all eight sites).

7. Additional comments. (250 words or less)

The Coastal Discovery Museum has played an important role in providing high-quality cultural and ecotourism opportunities on Hilton Head Island for 37 years. Since opening at Honey Horn in October 2007, we have made great strides in providing a unique experience for island visitors, impacting 1,492,701 people in the last fifteen years.

The Honey Horn property is like no other in the area. Visitors can discover some of the oldest buildings on the island and explore and learn about this island, its history, and its complex and fragile environment. A visit to the museum and a tour around the property give our guests a very special connection to Hilton Head Island.

This year we are featuring a number of new exhibitions, including Art Quilters of the Lowcountry, Lisa Watson's Avant Gardener, Gullah Portraits, and Conservation in the Classroom, among many others.

Honey Horn is a site for community and private events attracting tourists year round. This year we have continued to help out other organizations that needed outdoor meeting spaces. We have also continued to grow our wedding and event rental business and have 19 weddings already booked for 2023.

The continued success of this organization has come about through the support and hard work of volunteers, community organizations, and governmental entities. This dedication by so many has allowed the museum to capitalize on the natural attributes of Honey Horn and maintain a facility that showcases the history, beauty, and identity of the island.

C. FUNDING:

1. Please describe how the organization is currently funded. (100 words or less)

Coastal Discovery Museum operations are funded through multiple income streams. Grants total \$547,000; including ATAX, corporate, and federal grants. Our program, events, and rental revenues total \$335,000. Our store sales, membership, and individual donations total \$625,000. We receive \$92,775 in direct town funding. We earn approximately half of our operating budget through our business operations while still keeping the grounds open to visitors free of charge. Earned revenue reduces the public cost of operating this town-owned property and maintains it as one of the jewels of Hilton Head Island.

We printed and distributed 70,000 programming calendars and were able to place TV and print ads targeting tourists. Post-Covid we focused on more nimble electronic communications including social media and our website, but have also increased our outreach via emailed communications and direct mail marketing. We were able to work with a website/marketing firm to improve our digital strategy and start developing more content-rich stories for our website. Our Social Media marketing campaigns involving the Museum and the Farmers' Market - particularly targeting Facebook and Instagram - allowed us to continue to market the museum strongly in this space. This year we were able to resume major events, such as Art Market, but our fall program numbers were still significantly affected by the pandemic. We rolled out new private programs for families, and worked on significantly increasing our capacity to install larger exhibitions. Our vision for the future is to not only have one of the most amazing properties on the Island, but also to have a world-class exhibition program in all three of our historic buildings that will be open to the public.

3. What impact did this have on the success of the organization/event and how did it benefit the community? *(200 words or less)*

ATAX support, in combination with sound business practice, has allowed the museum to blossom. Visitors now return year after year as part of their vacation. Some even schedule vacations to be here for events like Art Market. Word-of-mouth advertising from residents and visitors about their positive experiences here have also helped, but the real driver of increased success has been our ability to add new programs and increase our offerings. We strived to be creative and to develop new impactful programs during the pandemic so we are now ready to attract and serve more visitors and to help make them better stewards of our

environment and protectors of the historic resources on the Island.

FY2022 had our highest Discovery House (museum) attendance ever (68,395) and was second highest for special events (22,340) indicating that our benefit to the community has grown as a result of our strategic investments. We believe that the museum, through our focus on history, culture, art, and the environment, can help bring the types of tourists needed for the future success of the town and the fulfillment of its vision. We are particularly pleased with the performance of our exhibition program which serves tourists, locals, and schools.

4. How does the organization measure the effectiveness of both the overall activity and of individual programs? (200 words or less)

We are constantly reviewing attendance, visitor comments, and replacing any underperforming programs. As a result, we have gradually improved our overall quality while keeping individual programs that serve tourists and trying new programs that connect us with residents. The pandemic led to us doing more small private programs for family groups and these remain highly popular. Based on previous surveys, 24% of people find out about us from locals, 36% from the internet, 19% from print, and 21% from other sources.

This high referral rate is due to the quality of our offerings and free admission thanks to ATAX funding.

Overall effectiveness is measured in increased mission-based attendance, serving as a community resource, and connecting visitors to cultural and ecotourism opportunities on the island. One of our strongest qualitative measures of success in this category is the quality of reviews we receive online from sources like TripAdvisor where we are the top thing to do on the Island after the beach and bike trails. We have received a certificate of excellence from TripAdvisor, we were named best museum of the Lowcountry by WTOC, and are recognized as an Affiliate of the Smithsonian

Institution and on the American Camellia Trail.

This letter is to confirm and specify the terms of our engagement with you and to clarify the nature and extent of the services we will provide. This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in July 1986 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.

Your organization is not required to file federal income tax returns unless it is subject to the tax on unrelated business income under section 511 of the Code. If your organization is subject to this tax, it must file an income tax return on the Form 990-T, Exempt Organization Business Income Tax Return. In this letter, we are not determining whether any of your organization's present or proposed activities are unrelated trade or business as defined in section 513 of the Code.


The law requires you to make your organization's annual return available for public inspection without charge for three years after the due date of the return. If your organization had a copy of its application for recognition of exemption on July 15, 1987, it is also required to make available for public inspection a copy of the exemption application, any supporting documents and the exemption letter to any individual who requests such documents in person or in writing. You can charge only a reasonable fee for reproduction and actual postage costs for the copied materials. The law does not require you to provide copies of public inspection documents that are widely available, such as by posting them on the Internet (World Wide Web). You may be liable for a penalty of \$20 a day for each day you do not make these documents available for public inspection (up to a maximum of \$10,000 in the case of an annual return).

Because this letter could help resolve any questions about your organization's exempt status and foundation status, you should keep it with the organization's permanent records.
