

Town of Hilton Head Island TOWN COUNCIL MEETING Tuesday, December 6, 2022, 3:00 PM MINUTES

1. Call to Order by the Town Manager

At 3:00 p.m., Mr. Orlando called the meeting to order. Expressing that every fours years, he has the pleasure as the Town Manager to call a meeting to order prior to the swearing in of the Mayor and new Town Council Members.

Mr. Orlando asked the Honorable Drew A. Laughlin to approach the podium to administer the Oaths of Office to the new Mayor and three new Town Councilmembers.

3. Call to Order for the Town Council Business

At 3:10 p.m., Mayor Perry called the meeting to order. He made some opening remarks, thanking Mayor McCann and Councilmembers Harkins and Lennox for their work and time serving the Town. Mayor Perry continued by discussing how he envisions the community and Town Council working collectively through respect, transparency, along with listening, and clear and accurate communication. He said he had met with each member of Town Council where they discussed their goals and how to achieve them.

Gray Smith: Addressed Town Council on his concerns with the U.S. 278 Gateway Corridor Project.

Mr. Stanford moved to elect Councilman David Ames as the Mayor Pro Tempore. Mr. Brown seconded. With little discussion, the motion carried by a vote of 6-0-1, Mr. Ames abstaining.

b. Public Planning Committee

Mayor Perry appointed Councilman Ames as the Chair of the Public Planning Committee. He also appointed Councilmembers Becker, Bryson, and Stanford as members and Councilmember Alfred as the alternate.

c. Community Services and Public Safety Committee

Mayor Perry appointed Councilwoman Becker as the Chair of the Community Services and Public Safety Committee. He also appointed Councilmembers Alfred, Brown, and Bryson as members and Councilmember Ames as the alternate.

11. Consideration of the Proposed Town Council Meeting Dates for Calendar Year 2023

Mr. Ames moved to approve the proposed Town Council meeting dates for calendar year 2023. Mr. Stanford seconded. With no further discussion, the motion carried 7-0.
