PLACEMENT Requirements for the Town of Hilton Head Island

□ Site plan (or survey with the items below drawn to scale) with the following:

- Proposed location of the home. If the home is replacing another home, signed document that previous home will be removed from the site and moved to another location off island.
- Applicable adjacent use and adjacent street setbacks and buffers
- Access, existing easements, ROW or other to show legal access to the property
- o Driveway, parking places, stairs, utility equipment and HVAC
- Septic system (if applicable)
- Tidal or freshwater wetlands (if home is adjacent to a tidal marsh)
 - Show the Ocean and Coastal Resource Management (OCRM) Critical line
 - Obtain stamped approval from OCRM
 - Show wetland buffer of 20' plus 5' setback from buffer
- \Box Proof of ownership of the home
 - A copy of the Bill of Sale for the home or
 - Copy of title showing the home has been signed over to you
- □ Home specifications regarding Wind Zone II
- □ Proof of ownership of the property where the home will be placed or Affidavit of Ownership Hold Harmless Permission to Enter Property:
 - If you own the property provide proof ownership:
 - Property deed or
 - Paid property tax receipt with your name on it
 - If you do not own the property, provide one of the following from the owner:
 - Affidavit of Ownership signed by the property owner or
 - Notarized letter from owner giving you permission to place your home on the property. The letter must include the tax district, map and parcel number.
- □ Proof of approved sewage disposal system:
 - \circ Paid letter of Service from the PSD or
 - Approval of the septic system design from DHEC
- □ If your home is in the Special Flood Hazard Area, a flood zone determination will be written on your Placement Approval form. You must arrange for a surveyor to put up a benchmark before the home is delivered to show the installer how high the home must be elevated.
- □ Copy of encroachment permit, if required. If the road is a State road, this will be a SC DOT permit, if a County road, it will be a Beaufort County Permit, and if it is a town road, it will be a Town of Hilton Head permit.

FINAL INSPECTIONS Requirement for the Town of Hilton Head Island

- □ Install the home on the lot per Town of Hilton Head requirements.
- □ Arrange for electrical services for your home. Do not connect power at this time.
- □ Connect electrical and HVAC system per Town of Hilton Head requirements.
- □ Obtain a Flood Elevation Certificate from a licensed surveyor, which certifies the elevation of the home.
- □ Provide the signed and notarized Mechanical Certificates from the electrician and the HVAC contractor and the Flood Elevation Certificate to the Community Development Department
- □ Arrange for final Town of Hilton Head inspections.

Town of Hilton Head Island MANUFACTURED HOUSING APPLICATION Process Narrative

The following Process Narrative is intended to provide Applicants with an understanding of the respective application process, procedures and Land Management Ordinance (LMO) requirements for obtaining application approval in the Town of Hilton Head Island. While intended to explain the process, it is not intended to repeal, eliminate or otherwise limit any requirements, regulations or provisions of the Town of Hilton Head Island's Land Management Ordinance. The Town of Hilton Head Island's Mission and Vision Statements help navigate staff to ensure that the goals outlined by Town Council are being met. As each project is being reviewed, Town staff will use the Mission Statement, Vision Statement, The Covenant for Hilton Head Island and the current Strategic Plan to guide their review. Compliance with these procedures will minimize delays and assure expeditious application review.

Please see the Town of Hilton Head Island Manufactured Housing Information Packet for more detailed information on the process of placing a manufactured home on Hilton Head Island.

Step 1: Obtain Approval of Water & Sewer	Applicant

Step 3: Staff Review and Action	Staff
On receiving an application, the Official shall review	v and make a final decision on the application.
Step 4: Register the Home in Beaufort County	Applicant
Once the Approval for Placement has been received	from the Town of Hilton Head, the Applicant shall
register the home in Beaufort County.	
Step 5: Obtain Manufactured Home Building	Applicant
