MEMORANDUM

TO: Town Council

RE: Proposed Resolution Authorizing the Participation by the Town in Federal Court Litigation by the South Carolina Environmental Law Project to Challenge the Permitting by the Federal Government of Seismic Testing and Drilling in the Atlantic Coastal Waters, Including Waters off Beaufort County and the South Carolina Coast

DATE: January 11, 2018

Recommendation: Staff has no recommendation.

Summary: The South Carolina Environmental Law Project (SCELP) has proposed litigation to challenge the current actions of the Federal Government in granting of permits in waters off South Carolina for seismic air gun surveying and oil and gas exploration on the grounds of environmental harm, economic damage, and community opposition. SCELP has requested the involvement and support of coastal municipalities to join in this litigation on the basis that SCLEP and its attorneys would represent the municipalities without any expense, attorney fees, or other financial contribution by the municipalities. This Resolution authorizes the Town to participate in this litigation by SCELP to seek to protect our pristine Atlantic coastline and the economic advantages that Hilton Head Island and South Carolina derive from a coastline free from environmental degradation.

Background: At the March 17, 2015 Town Council Meeting, Town Council voted 7-0 to oppose seismic testing off the coast of South Carolina on the grounds of environmental harm, economic damage, and community opposition. The Town joined other coastal states and communities in opposition when the Obama administration considered a five-year plan to permit drilling in the Atlantic from Virginia to Georgia, but as result, the Obama Administration abandoned its plan in the face of public opposition. On January 4, 2018, the Trump Administration released a draft plan that would open nearly all of the nation's coastal waters to seismic testing, offshore oil and gas drilling and exploration.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA, AUTHORIZING THE PARTICIPATION BY THE TOWN OF HILTON HEAD ISLAND IN FEDERAL COURT LITIGATION BY THE SOUTH CAROLINA ENVIRONMENTAL LAW PROJECT (SCELP) TO CHALLENGE THE PERMITTING BY THE FEDERAL GOVERNMENT OF SEISMIC TESTING AND DRILLING IN ATLANTIC COASTAL WATERS, INCLUDING WATERS OFF BEAUFORT COUNTY AND THE SOUTH CAROLINA COAST

WHEREAS, previously the Federal Government has removed the Atlantic Outer Continental Shelf (OCS) from any plans for offshore oil drilling, and has denied drilling permit applications for seismic air gun survey testing, citing environmental harms and coastal community concerns; and

WHEREAS, the seismic testing companies challenged the permit denials to the Department of the Interior, which has recently remanded the permit denials to the Bureau of Ocean & Energy Management (BOEM), effectively reviving the possibility of offshore drilling in the Atlantic Outer Continental Shelf; and

WHEREAS, on Thursday, January 4, 2018, the Federal Government published a proposal to permit drilling in most U.S. continental-shelf waters, including the Atlantic OCS, effectively opening up the waters off South Carolina, and Beaufort County, to seismic air gun surveying, and oil and gas exploration; and

WHEREAS, the South Carolina Environmental Law Project (SCELP) has proposed litigation to challenge the current actions of the Federal Government, and the granting of permits in waters off South Carolina for seismic air gun surveying and oil and gas exploration on the grounds of environmental harm, economic damage, and community opposition; and

WHEREAS, SCELP has enlisted the involvement and support of coastal municipalities to join in this litigation on the basis that SCELP and its attorneys would represent the municipalities in the litigation without any expense, attorney fees, or other financial contribution by the municipalities; and

WHEREAS, the Town of Hilton Head Island Town Council strongly believes that it is in the best interest of the Town of Hilton Head Island, and its citizens, for the Town of Hilton Head Island and other coastal communities to participate in this litigation effort by the SCELP to seek to protect our pristine Atlantic coastline and the economic advantages that Hilton Head Island and South Carolina derive from a coastline free from environmental degradation.

NOW THEREFORE, BE IT, AND IT HEREBY IS, RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA, THAT the Town Manager is authorized to acquiesce to the entry by the Town as a party in the proposed litigation by the SCELP to challenge the granting of permits in the Atlantic OCS, and other environmentally protected areas, for seismic air gun surveying and other oil and gas exploration, on the basis that such participation will be without expense, attorney fees, or other financial involvement by the Town.
