### **MEETING MINUTES**

- 1. Call to Order
- **2.** FOIA Compliance Public notification of this meeting has been published, posted, and distributed in compliance with the South Carolina Freedom of Information Act and the requirements of the Town of Hilton Head Island.
- **3.** Approval of Minutes <u>September 23, 2019</u> Councilman Lennox moved to approve. Councilman Harkins seconded. The September 23, 2019 Minutes were unanimously approved.

### 5. New Business

- a. Approval of Proposed 2020 Regular Meeting Dates Councilman Harkins moved to approve. Councilman Lennox seconded. The Proposed 2020 Regular Meeting dates were approved.
- b. Hilton Head Christian Academy Property Town's Right of 1<sup>st</sup> Refusal

Josh Gruber, Assistant Town Manager said I am sure you all are familiar with Hilton Head Christian Academy parcel and the re-zoning and approval that was provided by Town Council. In conjunction with the property owner moving forward with that development, there is a strip of land which is fairly narrow in width that runs along the front portion of this property along the roadway on which we have a right of first refusal. The property owner/developer has reached out to the Town with regard as to whether we would waive our right of first refusal on this parcel. Given that the Town has no intended use of the property and we have approved the development as it stands now, staff would make a recommendation that you recommend to Town Council that we authorize the waiver of first refusal on that parcel.

After a brief discussion, Councilman Lennox moved that the Committee recommend to Town Council that we authorize the waiver of first refusal on that parcel. Councilman Harkins seconded. The motion was unanimously approved.

### c. Status of Street Light Pilot Project – US278 Yacht Cove Drive

Jeff Buckalew, Town Engineer they solicited bids for the street lighting pilot project at Yacht Cove and 278. We received one bid of \$121,000 which is well over the Engineer's estimate and budgeted funds. We intend to re-solicit, re-advertise that project with another similar system. We are going to put a HAWK pedestrian crossing signal down at South Forest Beach Drive. We will reach out to Contractors. We directly emailed and solicited input from bidders last time, but only received that one bid from a firm out of Columbia. We will combine it with the HAWK signal and re-advertise and reach back out to Contractors that do this type of work and hopefully get more competitive bids.

Councilman Harkins said he recalls that this was to be a beta sight and if things went well we were going to multiply this throughout the Town. Mr. Buckalew said Town Council directed us to do a pilot. We received the necessary permits from SCDOT and our intention was to do a public opinion/survey to solicit feedback from the public and then go back to Town Council with a more programmatic plan. Councilman Harkins asked how many more installations will there be. Mr. Buckalew said when we looked at these unsignalized crosswalks on US278 there were 11 of those. We are going to rectify two of those in the Shelter Cove area by our Capital Improvements Projects. We are putting in a new traffic signal at the Sheriff's Office and we are going to put a pedestrian crosswalk by Hickory Tavern.

Councilman Harkins asked Mr. Buckalew if the end goal to populate throughout the Island more lights to provide more safety. Mr. Buckalew stated this was felt to be a mechanism to achieve more safety at those locations.

Councilman Lennox asked how long Mr. Buckalew thought the re-bidding process would take. Mr. Buckalew said they would be doing it within the next two weeks. I am getting the bid package together for the HAWK signal on South Forest Beach Drive and I will go through our Procurement Officer. We have to advertise for at least 14 days. We should have the bids back in mid-December. We will reach out to those types of Contractors and Vendors that do this type of work and try to pick their brains as to what we can do to make this solicitation more attractive.

Councilman Harkins said he is just trying to fast track implementation throughout the Island. This is a critical location. Josh Gruber said in his experience if the profit is significant enough, it doesn't matter the size of it as they will still make a profit. A lot of times you may only get one bidder because they have so much work already in front of them that they cannot practically bid on it. That may be the case here, or may not be the case. My recommendation would be to bid it out one more time because just getting one bid back may be an aberration and if you double down your efforts to make sure everyone is aware of it and if it comes back again with only one bid, then you know you have to change something because there is something in the bid itself that is causing a lack of competition.

Councilman Harkins asked Mr. Buckalew to go over the timeline again. Mr. Buckalew said we would re-bid within the next two weeks. We have to legally advertise for 14 days. We will get the bids in early December. Mr. Gruber said you are looking at 60 days from where we are at today. Hopefully you will get multiple bidders and you have brought the price back in line of what your expectations are and at that point you can move forward with it and get the pilot project in place and gage public feedback and response to that project itself. Assuming that it is favorably received, you can start looking at where we get the funds to do this on a much larger scale. Councilman Harkins said the downside on where we are is we are postponing up to 60 days addressing the one location. The upside is within the 60 day

period we may be in a position to help two locations. Mr. Gruber stated obviously that would have to come from Town Council and the appropriation of sufficient funds to allow us to do that, but I think if you can at least get the first one teed up in a manner in which your price points are going to within the lines of what your expectations are, it will make implementing it on an Island-wide scale much more feasible.

Chairman Grant asked if there was anyone from the public who wanted to speak. Mr. Brian Bobinchuck recalled that Palmetto Electric already had a plan and I thought it was kind of like a pre-approved situation. Mr. Buckalew said our first intent was to involve Palmetto Electric and not have to bid this project out and to have them install the lights, give us a service agreement and electric bills over a period of time and we talked to Palmetto Electric Engineers at length and they helped with some concept plans and did some preliminary engineering work themselves, but they did not want to get into the street light business. They advised that we hire a Consulting Engineer which we did who had permitted these types of projects through SCDOT in the past. We got the lighting design from them and we went to SCDOT to get approvals.

Mr. Joe Dimaria, a Yacht Cove resident the issue here concerns me for many reasons and should be of grave concern for you and speaks to our priorities. It has been over a year now that Mr. Bobinchuck lost his daughter at that intersection and there seems to be a lot of talk and proposals but I do not see anything happening. I think we spend our money is a reflection of what our priorities are. This is community safety – not just in Yacht Cove, but throughout the Island. As a Town we can do a better job of how we spend our money.

Linda Crosser a Yacht Cove resident asked if you are combining this with the one on South Forest Beach how will you know what the cost is going to be for the other 8 if they are combined. Mr. Buckalew said we will definitely keep them separate – they are separate funding accounts so there will be two separate bid packages. The Contractors that do that type of work could bid both of them. It is very similar type work. That is the benefit. Councilman Harkins said the bidder is compelled to bid for both and when you award the Contract you will award it to one company? Mr. Buckalew said that is not necessarily true. We will bid them together to provide more quantity of work but it hasn't been fully determined yet with Mr. Liggett and the Procurement Officer, but I can see bidding them both together to attract more bidders, but if Firm "A" was low on the street lights and Firm "B" was low on the HAWK signal we could give it to two separate bidders. Councilman Harkins thought the purpose was to enlarge the project so that you might get more people in and now you are telling us that you are going to bifurcate it if the costs are lower for one side or the other.

Scott Liggett said we desire to do whatever we believe is most advantageous to the Town – maximize the number of folks that might be interested in the project and if it is in our interest, we may reserve the right to award separate pieces. The advice to any of the bidders would be to sharpen your pencil as tight as you can on both of those projects because we may just do that and break it apart if we think it is most advantageous to the Town.

Councilman Harkins said if we could expedite the process by acting on the application that is before us now, albeit over budget, on a macro level that might be in the best interest of the Town. Even though it is over budget, I think we ought to go ahead. Mr. Liggett said what we would really like to do as has been said is re-bid this project immediately. From an over budget standpoint, my view on that is a little bit different than what has been stated before in that in FY2019 we had \$100,000 which was allocated to pathway accessibility and safety. Not long after the start of FY2019, this initiative emerged and we have been working to address it in increments around the Island. Right now we have \$67,000 that was brought

forward from that budget year that was augmented with \$80,000 that you may recall was allocated for FY2020. Right now, to my mind, we have \$147,000 in available funds when you coagulate FY2019 funds with FY2020 funds. Right now that would be the funding source for anything that we advance. The \$80,000 estimate is something that we also need to pay attention to in that the bids came back significantly above that estimate which the Procurement Code requires that we revisit/reset to make sure that the estimate and the market are as synched as we can. Councilman Harkins said he does not see a true benefit of slowing this process down by developing another RFP for another location since when those bids come in we could end up with two Contractors, one for one site and one for the other. Why don't we just create focus – we already have one bid – we pull it together – why don't we throw it out again for that one site and see what happens. Mr. Liggett said we have what staff sees at this point of similar work that would be of interest to similar Contractors. We can discuss with the Manager how we best want to implement both of those projects, but to our mind we see something that can conceivably be combined given than the higher than expected bids on the standalone crosswalk lighting program.

Councilman Harkins said he does not see the downside of sending out the package again for one location and being in the position within 14 days to say up or down. I would get the same package out to the same population – 14 days turnaround and we could be in a position here in two to three weeks from now for a "go" "no go." Mr. Liggett said he is happy to share that perspective with the Manager, along with staff's perspective. Ultimately we will do what the Town Manager directs us to do. At the staff level we will take direction and guidance from him.

Councilman Lennox said what we are seeing is typical over the past couple of years in receiving inflated bid proposals on the Island. There is so much work off the Island that a lot of these Contractors don't need the hassle to come on the Island that a project presents. I think it makes sense combining the work in an effort to get more response. I am sensitive to the time to the extent that we got proposals back in early December or even late November I would support holding a Special Meeting of this Committee to expedite this. This project is important at Yacht Cove, but it is also important for the remaining crosswalks that we are going to consider. Because of that, I am very sensitive to the timing and I think receiving a bid 50% more than what we had originally forecast is significant enough that we have to go out and get additional bids, either confirming that or not.

Several Hilton Head Island residents spoke in favor of moving this item forward as soon as possible due to the extremely dangerous area of US278 and Yacht Cove Drive.

Councilman Harkins stated if we could be in a position within four weeks from now, going out for the two, I can live with that. I think we need to send a direction to staff that we want to have before us a firm recommendation, based on bids on or before our next meeting on November 25, 2019. Chairman Grant agreed. Councilman Harkins asked Mr. Gruber for his comments. Mr. Gruber said we should not have any issues with getting a bid turned around and getting back to you by this time next month. We will move forward with re-issuing it with a truncated timeline to have a response back to you at your meeting next month.

#### d. Hands Free Driving Resolution

Josh Gruber said this initial discussion came about as a result of the State of the Region luncheon that was held a couple of months ago. Lisa Sulka, Mayor of Bluffton challenged the other municipalities within Beaufort County to support the Town of Bluffton in their stance in encouraging the General Assembly to adopt legislation to require the operation of a vehicle free from inference of distracted driving such as a cell phone, eating food, etc. The impetus of this is obviously a safety considerations with regard to people operating vehicles. My understanding is that the States that neighbor South Carolina have in fact put this same legislation already into effect. Essentially the Resolution that you have before you is a Statement of Policy suggesting that the General Assembly exercise their lawful authority to change the State Code regulating this kind of behavior while operating a motor vehicle. It is not actually passing any kind of law itself, it is just a statement that we would support the General Assembly in their pursuit of passing such a law and showing solidarity with some of the other Municipalities in Beaufort County that have already adopted a similar Resolution.

After a brief discussion, Councilman Harkins moved to that we recommend to Town Council support of this direction. Councilman Lennox seconded. The Motion unanimously passed.

### e. Mitchelville Lane Right of Way Acquisition – Status Report

Scott Liggett said this particular discussion item we were intending to have the support of Curtis Coltrane here as it is more of a legal briefing than an engineering briefing. We are seeking your indulgence to reschedule this item on a future meeting agenda. Chairman Grant said to put it on a future meeting agenda.

### 6. Adjournment

Councilman Harkins moved to adjourn. Councilman Lennox seconded. The Meeting was adjourned at 9:58 a.m.

# TOWN OF HILTON HEAD 3RD QUARTER 2019

### DATA SOURCE/CRITERIA

All law enforcement agencies in the state compile incident-based data on crimes occurring in their jurisdiction. While one incident can result in multiple offenses being tracked in the local system, only data that meets the national criteria is forwarded to the SC Law Enforcement Division.

Currently if a burglary is reported and property stolen, two offenses are tracked locally but only the major crime, burglary, is reported using the South Carolina Incident-Based Reporting System. This data is collected by SLED and then forwarded to the FBI, which administers the Uniform Crime Reporting (UCR) program.

The Beaufort County Sheriff's Office will begin using the UCR criteria to account for crime in this report so that it will more closely match the data published by the FBI.


Crimes Against Persons will include Murder, Aggravated Assault, Robbery and Forcible Rape.

Crimes Against Property will include Burglary, Larceny and Auto Theft. Vehicle Collisions will remain the same as they are not reportable UCR crimes.

This report is based only on the crimes that occurred on Hilton Head Island.

These statistics are compiled using the following Uniform Crime Reporting (UCR) criteria:

**Murder and non-negligent manslaughter:** The willful killing of one human being by another. Any death due to injuries received in a a fight, quarrel, assault or commission of a crime is classified in this category.


**Aggravated Assault:** An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury (involving apparent broken bones, loss of teeth, possibly internal injury, severe laceration, loss of consciousness due to injury, etc.)

**Robbery:** Taking or <u>attempting</u> to take, under confrontational circumstances, anything of value from another person by <u>force or threat of force</u> or violence and/or by putting the victim in fear of immediate harm.

**Forcible Rape:** Any sexual act directed against another person, forcibly and/or against the persons will; or not forcibly or against the person's will where the person is unable to give consent. A person may **unable** to give consent due to: very young or very old, mental or physical incapacity, intoxication, the influence of drugs.

**Burglary/Breaking & Entering:** The UNLAWFUL ENTRY into a building or other <u>structure</u> with the <u>intent</u> to commit a serious crime or theft.

**Structure:** A structure is defined as a building or walled enclosure which can be enclosed on all sides by closing doors or windows.


Motor vehicles, motor homes, trailers and other mobile property are <u>NOT</u> structures. Some mobile property may be made immobile.

**Larceny:** The unlawful taking of property from the possession or constructive possession of another person. Types of larceny include: pocket picking, purse snatching, shoplifting, theft from a building theft from coin operated machine or device, theft from a motor vehicle, theft of motor vehicle parts and thefts from enclosures, etc, and from residences where **no unlawful entry** of a structure is involved.

**Motor Vehicle Theft:** Theft of a motor vehicle. This <u>does not</u> include using a motor vehicle without the expressed consent of the owner.

Per the request of the Chairman, the attached SCDNR publication is provided to summarize coyote control actions which landowners may consider.



### **Coyote Control - What a landowner CAN do in South Carolina**

**Hunting/Shooting:** There is no closed hunting season on coyotes. Coyotes may be hunted year 'round on private lands' with a valid hunting license. A free depredation permit can be issued to landowners that do not have a hunting license (see Depredation Permits). On private lands, coyotes may be hunted with any firearm during daylight hours at any time of the year.

Night Hunting Coyotes: Coyotes may only be hunted at night under the following conditions:

- By registering\* the property with DNR online at: www.dnr.sc.gov/nighthunt
- In accordance to a DNR-issued depredation permit (see Depredation Permits section below)

\*The landowner must register with DNR any properties on where night hunting activities for coyotes are going to take place. This registration is required annually as prescribed by DNR for each property. An annual summary of night hunting activities is required before a property can be re-registered the following year. This registration also allows for the night hunting of armadillos, feral hogs, and coyotes for every registered property. For more information see <u>www.dnr.sc.gov/nighthunt</u>. (SC Code of Laws §50-11-700 et seq.)


Persons convicted of certain night hunting violations during the previous five years are ineligible to hunt coyotes at night (SC Code of Laws §50-11-715). <u>A permit is required from a local DNR Law Enforcement Officer for anyone to hunt or shoot coyotes</u> at night on any property that is not currently registered for Night Hunting with DNR.

Bait, Electronic Calls: The use of bait and electronic calls is allowed for hunting coyotes during the day or night on private lands statewide. The use of any legal firearm, bow and arrow, or crossbow is allowed on private lands statewide.

**Trapping:** The normal trapping season for licensed trappers is Dec. 1 - Mar. 1. HOWEVER, a property owner may obtain a free depredation permit to trap outside of the normal trapping season and/or without a trapping license (see Depredation Permits section below for more information).

- Legal Traps: (A separate <u>Trapping Regulations</u> brochure is available)
- Snares: The use of snares is *illegal* for use in land sets. All coyote sets are considered land sets.
- Foothold traps: Trap size must be 5 3/4" or smaller for land sets (see Figure 1 below). All covote sets are generally considered land sets.
- Live traps: In certain situations coyotes have been caught in live traps, but in general these traps are large and generally much less effective.

Except for licensed trappers during the trapping season (Dec. 1 – Mar. 1 and 30 days after), the possession and relocation of live coyotes is illegal!



**Depredation Permits:** A depredation permit allows a property owner (or their designee) to trap or shoot damage-causing coyotes without any kind of license or season restrictions. The permit is FREE and available from any of DNR's offices or conservation officers. These permits may also be obtained over the phone. This permit will be good for 30 days for a specific site (such as Mr. Smith's farm).

- The 100-yard Exemption: Within 100-yards of the property owner's residence (so long as you are still on your own property), coyotes may be trapped or shot (if it is legal to discharge a firearm at the property's location) WITHOUT ANY KIND OF LICENSE OR PERMIT. This exemption applies to the property owner or his/her designee (such as a friend, relative, or any other person designated by the property owner).
- Depredation Permits to shoot at night: Except as provided under normal night hunting regulations as stated in the Hunting/Shooting section above, a depredation permit to shoot coyotes at night MUST be obtained from a local DNR conservation officer (check local firearms ordinances first). If you do not know a local DNR officer, contact the DNR at 803-955-4000 or 1-800-922-5431 and ask to have a local DNR officer contact you.
- Predator Management Permits: A special depredation permit to trap coyotes for wildlife management purposes and not for traditional depredation issues such as livestock losses and problems around the home. This permit is specifically for hunt clubs and other large properties primarily used for hunting. Only valid outside of trapping season (Mar.1 - Nov.30). Year end harvest report required. Issued by the Furbearer Project in Columbia Office.

Non-Lethal Options: These options are for reducing coyote damage without removing the coyote.

- Cultural Techniques: Confinement of livestock and small pets especially at night can lessen predation problems. Cleaning up brushy, grassy and weedy areas that attract small mammals (rabbits and rodents – a coyote's primary food source) can make your property less appealing to coyotes.
- Guard Animals: Certain animals have been successfully utilized as guard animals for livestock. Certain dog breeds (such as Great Pyrenees), donkeys, mules, and llamas have been used to protect livestock.
- Wire Barriers: Fences and fencing can prevent coyotes from entering an area if properly constructed. Buried aprons can prevent digging under a fence and overhangs or electric wires can prevent climbing over a fence. The DNR Coyote Brochure discusses fences in more detail.

Wildlife Control Operators (WCOs): For those property owners that wish to pay someone to trap coyotes for them (usually for a fee), the list of Wildlife Control Operators is available from any local DNR office or online at http://www.dnr.sc.gov/wildlife/control.html . These companies and individuals perform wildlife control services on a contractfee basis. WCOs are not DNR employees and are not affiliated with the DNR. It is important to ask for references before hiring a WCO. Have all fees and guarantees in writing.

### Office of Cultural Affairs' Arts & Cultural Council of Hilton Head

#### Mission

Our mission is to promote and support Hilton Head Island as a vibrant and diverse island that is celebrated locally, regionally and nationally for the ways in which arts and culture enrich and enhance the community.

We use a broad definition of arts & culture. The definition includes the fine arts but also such creative expressions as traditional, ethnic, and folk art, music, the history and heritage of the island, landmarks, parks, and natural resources and sites.

The goal is for our definition of arts and culture to encompass our community's customs, beliefs and traditions.

### Vision

Our vision is for a thriving cultural economy in our community.

#### **Board and Terms**

The Arts and Cultural Council ("council") shall consists of two (2) committees each consisting of up to ten (10) members appointed by the director of cultural affairs ("director") The director shall seek a diverse mix of members with experience in local entertainment, arts, culture, and heritage endeavors as well as experience in professions it deems appropriate to fulfilling the mission of the committee. The committee members shall be appointed for a term of three (3) years that may role into a second term if agreed upon by the member and the director. No member may serve more than two (2) successive terms. This limitation shall not prevent any person from being appointed to the committee after an absence of one (1) year. All terms shall be established to end on June 30 of the appropriate year.

The full council will be divided into two (2) committees. Each committee with consist of up to ten (10) members. The committees will work actively on their defined goals as defined below:

- Advocacy Committee: The Advocacy Committee will initially consist of members of the previous Culture and Arts Advisory Committee. The focus of the work of this committee will involve tactics around defining and promoting the Town's creative economy, leveraging the power of the arts, culture and creativity to serve the community's interest while driving a broader agenda for change, growth and transformation in a way that also builds character and quality of place. The three pillars of this work will focus on Education, Quality of Life, and Marketing/Cultural Tourism.
- 2. Crescendo Committee: The Crescendo Committee will initially consist of members of the previously known Arts and Cultural Council of Hilton Head. The focus of the work of this committee will involve the planning, execution, and promotion of the annual Crescendo festival, the month-long celebration of arts and culture on Hilton Head Island produced in coordination with National Arts and Humanities month. The committee members will be identified to fill specific roles necessary for producing the festival.

Each representative must sign and place on file the Arts & Cultural Council Conflict of Interest Policy.

#### Meetings

Regular Meetings: The Arts & Cultural Council of Hilton Head meets monthly from August through June with meetings rotating quarterly between the full council and each committee. The Executive Committee will meet every other month.

Regular meetings will be held the third Wednesday of each month at 9:30 AM. The monthly schedule will be as follows:

January: Crescendo Committee February: Advocacy Committee March: Full Council April: Crescendo Committee May: Advocacy Committee June: Full Council July: Hiatus August: Crescendo Committee September: Advocacy Committee October: Full Council November: Crescendo Committee December: Advocacy Committee

### Section 2 – Special Meetings

Special meetings may be called by the director or executive committee.

#### Section 3 – Notice of Meetings

The secretary of the executive committee will notify all members at least one week in advance of meetings with an agenda and minutes from the previous meeting.

#### **Officers and Duties**

Four officers, elected by the respective members of each committee, will serve as the Executive Committee for ACCHH. Each committee of the council will elect two members to serve as officers. The Executive Committee will serve 2 year terms.

Except for the power to amend the articles of incorporation and bylaws, the Executive Committee shall have the power and authority of their respective committees in the intervals between meetings of the council and is subject to the direction and control of the full council.

The Board of the Council will nominate and vote upon the Officers at the June meeting at the end of the Town's fiscal year.

#### **ORDINANCE NO. 2019-**

#### **PROPOSED ORDINANCE NO. 2019-30**

#### AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA (1983), BY DELETING CHAPTER 8 (TOWN CULTURE AND ARTS ADVISORY COMMITTEE) OF TITLE 8 (BEACHES, WATERWAYS, RECREATIONAL AREAS AND ARTS); AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Town Culture and Arts Advisory Committee was created by Ordinance 2017-02 adopted on March 7, 2017; and

WHEREAS, Town Council's goal for the Town Culture and Arts Advisory Committee was to aid the Culture and Arts Network Director in its duties and responsibilities in the development and implementation of a plain for the enhancement of the Entertainment, Arts, Culture, and Heritage Industry; and

**WHEREAS**, the Town Culture and Arts Advisory Committee has completed its mission as defined by Council, and as such, should be consequently dissolved; and

WHEREAS, following the dissolution of the Cultural and Arts Advisory Committee, it is the intent of the Town to establish a new Arts and Cultural Council who will exist as an advisory body outside of Town Government and who will act in support of the actions of the Culture and Arts Network Director to continue supporting the vision of maintaining a thriving cultural economy within the Island's community.

#### NOW, THEREFORE, BE IT ORDERED AND ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF HILTON HEAD ISLAND, SC; AND IT IS HEREBY ORDERED AND ORDAINED BY AND UNDER THE AUTHORITY OF THE SAID TOWN COUNCIL, AS FOLLOWS:

**NOTE:** <u>Underlined and bold-face typed</u> portions indicate additions to the Municipal Code. Stricken portions indicate deletions to the Municipal Code.

<u>Section 1.</u> That Chapter 8 of Title 8 of the Municipal Code of the Town of Hilton Head Island, South Carolina, is hereby deleted as follows:

#### "Town Culture and Arts Advisory Committee."

Sec. 8-8-10. - Creation.

- (a) The town culture and arts advisory committee ("committee") is hereby created pursuant to the authority of the Code of the Town of Hilton Head Island, South Carolina, chapter 13, section 2-13-10, [titled] "Establishment," and shall have the organization, powers and duties set out in this chapter.
- (b) The committee shall consist of up to twelve (12) members appointed by the town council. The council shall seek members with experience in local entertainment, arts, culture, and heritage endeavors as well as experience in professions it deems appropriate to fulfilling the mission of the

committee. The committee members shall be appointed for a term of three (3) years; provided, however, that no member may serve more than two (2) successive terms except for extraordinary eircumstances where town council believes it to be in the best interest of the community to have a continuation, for a specified period, of a particular member of the commission. This limitation shall not prevent any person from being appointed to the committee after an absence of one (1) year. All terms shall be established to end on June 30 of the appropriate year and members shall serve until their successors are appointed and qualified. Vacancies shall be filled by the town council for the balance of the unexpired term. The town council may remove a member for cause after written notice and public hearing. The committee shall elect a chairman and a vice chairman from its members who will serve for one year terms. It shall appoint a secretary who may be an officer or employee of the town or of the committee. No member of the committee may hold elected public office in the town or the county. The committee shall meet at the call of the chairman or at such times as the committee may determine. The committee shall adopt rules for the conduct of business and shall keep a public record of all proceedings and shall record the votes of each member on each question. The committee shall file reports on its activities to the town council on a quarterly basis.

(c) In the fulfillment of its duties as outlined herein, the committee shall have access to such town facilities and staff assistance, subject to the control and direction of the manager, as it may reasonably require.

Sec. 8-8-20. - Powers and duties.

The committee will work actively and collaboratively with the culture and arts network director ("director") to achieve town goals as follows:

- (1) Work with the director to create an entertainment, arts, culture and heritage vision and strategy that complements the town's vision.
- (2) Support the director in elevating the profile of Hilton Head Island's entertainment, arts, culture and heritage offerings to residents and visitors by developing and implementing a comprehensive marketing and communications plan. Elements of that plan should demonstrate best efforts to include, but not be limited to, the following:
  - a. Integrating into Hilton Head Island branding and marketing efforts including targeted marketing programs such as found within the town's designated marketing organization.
  - b. Facilitating a one stop shop hub for information about the entertainment, arts, culture and heritage community, products and services.
- (3) Assist the director in establishing Hilton Head Island as a premier entertainment, arts, culture, and heritage destination including, but not limited to, obtaining and maintaining a South Carolina Arts Commission Cultural District status.
- (4) Work with the director to integrate entertainment, arts, culture, and heritage into the daily fabric of Hilton Head Island life. Activities include, but are not limited to:
  - a. Formalizing a partnership between schools and the entertainment, arts, culture and heritage communities to provide greater exposure to such communities for students and support school based entertainment, arts, culture, and heritage programs.
  - b. Expanding the variety and number of public art displays.
  - c. Sharing entertainment, arts, culture, and heritage resources and opportunities across the diverse island population.
  - d. Integrating entertainment, arts, culture, and heritage assets into existing and new island festivals.

- (5) Assist the director in developing a plan to identify additional funding and measure plan progress through:
  - a. Exploring and applying for grants and other private/public funding vehicles.
  - b. Researching and designing a measurement system to track progress and demonstrate the value to the community of the entertainment, arts, culture, and heritage assets in terms of quality of life and economic impact.
- (6) Provide annual performance feedback to the appropriate supervisor based on predetermined goals and outcomes.

<u>Section 2</u>. <u>Severability</u>. If any section, phrase, sentence or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

<u>Section 3.</u> <u>Effective Date</u>. This Ordinance shall be effective upon adoption by the Town Council of the Town of Hilton Head Island, South Carolina.
