#### **RECOMMENDATION:**

Staff recommends the Parks and Recreation Commission review the Conceptual Master Plan for proposed improvements for Patterson Family Park and forward a recommendation of approval to Town Council.

#### SUMMARY:

Based on Community input and recommendations approved through Our Plan and the 2020 Parks & Recreation Master Plan, Town Council approved funding in the FY22 and FY23 Capital Budget to develop a small neighborhood park at the property currently known as Patterson Family Tract. The funding sources for this project include ATAX Beach Fee, Hospitality Tax, TIF Revenue, and a Community Development Block Grant. The total FY24 budget is \$2,200,000.

#### BACKGROUND:

The Patterson Family Tract was sold to the Town by the Patterson Family in 2001, with the intention of developing the waterfront portion into a future neighborhood park. The property was purchased through a bond referendum and real estate transfer fee, and it's zoning is restricted to Parks and Recreation Space.

In July 2022, Town Staff and the consultant team prepared a preliminary project scope for the planning and design of the Patterson Family Park, which will be located on the upland area of a 3.5-acre undeveloped parcel within the Historic Marshland Community. This will be the first public park on the Marshland Road side of Broad Creek. The park will serve as a passive use space with amenities for immediate neighborhood residents, while also providing a unique destination location for visitors. These neighborhoods include the Historic Marshland and Chaplin communities and the Habitat for Humanity community along Alex Patterson Road. The presence of wetlands on the site and spectacular views of Broad Creek will provide special opportunities for integration of nature and design.

Community engagement to solicit input and feedback to identify key stakeholders and further refine the scope of work also began in July 2022. This provided the project team with initial ideas to develop a preliminary concept plan for the space. During this phase of work, the team also identified development challenges regarding vehicular access to the site, which is bisected by a large area of critical wetland. Staff reached out to adjacent landowners to discuss potential strategies and opportunities for access via land acquisition.

During the February 2023 Town Council Workshop meeting, the project team presented a preliminary master plan showcasing a small neighborhood park with amenities including bike and pedestrian circulation, passive recreational uses, vehicular parking, activity zones for adults and children, sheltered space and viewsheds to Broad Creek. The Conceptual Master Plan for Patterson Family Park includes the following components:

- Safe pedestrian connectivity with crosswalks to the existing pathway network
- Vehicular access that accommodates park users, emergency vehicles and adjacent property owners
- Internal pathways with lighting and interpretation
- Passive open lawn space
- Interactive playground with STEAM (Science, Technology, Engineering, Arts & Math) features
- Adult activity zone with outdoor fitness stations
- Covered pavilion with restrooms, tables, and seating areas
- Overlook area with views of Broad Creek
- Integration of existing natural features such as specimen trees and wetland areas
- Oyster tables with roasting areas

In April 2023 Town Council approved the pursuit of land acquisition for an adjacent 1acre undeveloped parcel owned by Mr. Herbert Ford, which will provide the necessary vehicular access to the park while also providing unrestricted access for adjacent property owners and emergency vehicles. Land acquisition is currently underway.

To further refine the park plans, the project team sought additional consultation from Jasmine White, an Island-based designer. Beginning in August 2023 Jasmine conducted a series of interviews with key Native Islander community members to include Dr. Louise Cohen and Mr. Thomas C. Barnwell, Jr. In her work she was able to uncover more cultural and historical aspects of the Patterson Family and property, which generated unique design ideas that could be integrated into the park and ultimately refined the proposed Conceptual Master Plan. This effort included the addition of the following key components:

• General history of the land and family

- Creation of a "Dominant Theme" for the park related to farming
- Identification of specific play features
- "Peace and Participate" features such as the pavilion, lawn, and observation platform

#### NEXT STEPS:

Beyond the Parks and Recreation Commission (PRC) meeting to review the Conceptual Master Plan, the next steps include:

- Refinements to plans based on Community, PRC and Town Council feedback
- Town Council Approval December 2023
- Final Design and Permitting CY 2024

#### HISTORY OF THE LAND

- Land donated by the Taylor Family
- Land most notably occupied by the family of Genie and Isaiah McKnight
  - Relatively small family
  - Known for being farmers and fishermen

- Dominate Theme
  - Farming was an essential way of life on Hilton Head. Many families were known for the dominant crop that they harvested. In honor of the McKnight family's history of small family farming and fishing, Taylor Park will display a contemporary take on the peace that existed in their lives as Islanders in a communal relationship with the land.
  - This park will invite visitors to experience the peaceful play and inspiring serenity our island has to offer, while reflecting on the richness of the cultural history.
- Play Features
  - $\circ$  Swings
    - Stylistically oversized
    - Distinctly varying in size
      - Singular, 2 person, and 3 person swings
    - Designed from oak and nautical rope made to mimic the look of moss to allow the swings to feel like they're growing organically from the trees
    - Engraved with Gullah names, words, sayings or phrases
    - Include an adaptive swing
    - Nautical rope, climbable rope swings
  - Fisherman's Knot Board
    - Interactive board with several strands/bundles of attached nautical rope that have instructions detailing how to tie various fisherman's knots and explaining when, why, and how they might be used
  - Tree House
    - A treehouse that fits in so naturally, it looks like it's grown out as an extension of the tree, yet modern in design
    - Multiple points of access including a nautical rope ladder to climb
  - Fishing Boat/s
    - A small fishing boat play structure with wooden attachments that mimic fishing poles that are engraved with the types of fish that would have been caught and quotes in Gullah related to fishing
    - Boat covered in a mural designed with Gullah art in the style of Jonathan Green

- A "Fisherman's Journal" written in Gullah as if someone is offering a simple yet informative explanation in a storytelling format.
  - Posted on a freestanding pole with a sign that can be manually spun in order to read more about the process and patterns of a Gullah fisherman at that time.
- Hopscotch through history that tells a story as you move forward
- Peaceful Participation Features
  - Pavillion
    - A place of sheltered connection for gathering, dining, celebrating, relaxing
    - Modern structure that feels like an design-forward farmhouse patio
  - Lawn
  - Paved Walking Paths
    - Designed to allow for contemplative weaving around the perimeter of the park and in between the trees
    - Designed to gracefully lead visitors to meander from path, to swing, to grass, to learning and resting
    - A sort of labyrinth style meditative design paved with symbols, words, and stories stamped into concrete along the way
      - The shape and flow of the path would be designed in a way that it feels like the weaving of a Gullah Basket
  - Wind Chimes
    - Locally designed wooden windchimes that add to the serenity of the space
  - Garden
    - Vibrant, colorful native plantings with descriptive markers naming the plants and sharing stories of how various agricultural elements; flowers, plants, seeds, leaves, etc. were utilized for a variety of purposes
  - Bike Racks
    - Designed with engraved silhouettes of people fishing
  - Add interest to the cross walks and parking spaces with painted murals by local artists
  - A signature symbol in honor of the Indigo farming on the Island

#### **RECOMMENDATION:**

Staff recommends the Parks and Recreation Commission review the Conceptual Master Plan for proposed improvements for Taylor Family Park and forward a recommendation of approval to Town Council.

#### SUMMARY:

Based on Community input and recommendations approved through Our Plan and the 2020 Parks & Recreation Master Plan, Town Council approved funding in the FY22 and FY23 Capital Budget to develop a small neighborhood park at the property currently known as Taylor Family Tract. The funding sources for this project include Real Estate Transfer Fee, Sale of Land, and a Community Development Block Grant. The total FY24 budget is \$1,000,000.

#### BACKGROUND:

The Taylor Family Tract was donated to the Town by the Taylor Family in 1991, with the intention of it being developed into a future neighborhood park. The property zoning is restricted to Parks and Recreation Space.

In July 2023, Town Staff and the consultant team prepared a preliminary project scope for the planning and design of the Taylor Family Park, which will be located on the 4.9acre undeveloped parcel within the Historic Squire Pope Community. The property contains approximately 1-acre of wetland area, and the upland portion of the park will serve as a passive use space with amenities for immediate neighborhood residents such as the Historic Squire Pope community as well as others along Wild Horse Road, Gumtree Road, and Squire Pope Road. In addition, the park will provide a unique destination location for visitors. The presence of several large live oaks, young maritime woodland vegetation and a freshwater wetland on the site provides an opportunity for integration of nature and design. Community engagement to solicit input and feedback to identify key stakeholders and further refine the scope of work also began in July 2023. This provided the project team with initial ideas to develop a preliminary concept plan for the space. During this phase of work, the team also sought additional consultation from Jasmine White, an Island-based designer.

Beginning in August 2023, Jasmine White conducted a series of interviews with key Native Islander community members to include Dr. Louise Cohen and Mr. Thomas C. Barnwell, Jr. In her work she was able to learn more about the Taylor Family and discovered an even deeper historical connection with the McKnight Family, who owned the property for a long period of time between post-Civil war and the 1950's. This effort helped generate unique ideas that will be integrated into various design components for the park.

The project team presented a Preliminary Master Plan to the community in October 2023 showcasing a small neighborhood park with amenities including bike and pedestrian circulation, passive recreational uses, vehicular parking, activity zones for adults and children, and sheltered space. The Conceptual Master Plan for Taylor Family Park includes the following components:

- Safe pedestrian connectivity with a crosswalk to the existing pathway network
- Vehicular access that accommodates park users and emergency vehicles
- Internal pathways with lighting and interpretation
- Passive open lawn space
- Interactive playground with STEAM (Science, Technology, Engineering, Arts & Math) features
- Adult activity zone with outdoor fitness stations
- Covered pavilion with restrooms, tables, grills, and seating areas
- Integration of existing natural features such as specimen trees and wetland areas General history of the land and family
- Creation of a "Dominant Theme" for the park
- Identification of specific play features such as STEM
- "Peace and Participate" features such as History Path, Cultural Garden, and inclusion of a 55" Pecan tree that served as a meeting place for Gullah Elders throughout the last century
- Integration of new pecan tree plantings within the proposed landscape



    - Storytelling plaques embedded along wood and cable fencing in the shape of a semicircle
  - Paved Walking Paths
    - Gullah symbols, words, stories, stamped into concrete along the way
  - Pedestrian Bridge
    - Engraved Gullah poetry written across the bridge
  - Add interest to the cross walks and parking spaces with painted murals by local artists
  - A signature symbol in honor of the Indigo farming on the Island

#### TAYLOR PARK

Wild Horse Road 4.9 Acres

#### HISTORY OF THE LAND

- Land donated by the Taylor Family
- Land most notably occupied by the family of Genie and Isaiah McKnight
  - Relatively small family
  - Known for being farmers and fishermen

- Dominate Theme
  - Farming was an essential way of life on Hilton Head. Many families were known for the dominant crop that they harvested. In honor of the McKnight family's history of small family farming and fishing, Taylor Park will display a contemporary take on the peace that existed in their lives as Islanders in a communal relationship with the land.
  - This park will invite visitors to experience the peaceful play and inspiring serenity our island has to offer, while reflecting on the richness of the cultural history.
- Play Features
  - $\circ$  Swings
    - Stylistically oversized
    - Distinctly varying in size
      - Singular, 2 person, and 3 person swings
    - Designed from oak and nautical rope made to mimic the look of moss to allow the swings to feel like they're growing organically from the trees
    - Engraved with Gullah names, words, sayings or phrases
    - Include an adaptive swing
    - Nautical rope, climbable rope swings
  - Fisherman's Knot Board
    - Interactive board with several strands/bundles of attached nautical rope that have instructions detailing how to tie various fisherman's knots and explaining when, why, and how they might be used
  - Tree House
    - A treehouse that fits in so naturally, it looks like it's grown out as an extension of the tree, yet modern in design
    - Multiple points of access including a nautical rope ladder to climb
  - Fishing Boat/s
    - A small fishing boat play structure with wooden attachments that mimic fishing poles that are engraved with the types of fish that would have been caught and quotes in Gullah related to fishing
    - Boat covered in a mural designed with Gullah art in the style of Jonathan Green

- A "Fisherman's Journal" written in Gullah as if someone is offering a simple yet informative explanation in a storytelling format.
  - Posted on a freestanding pole with a sign that can be manually spun in order to read more about the process and patterns of a Gullah fisherman at that time.
- Hopscotch through history that tells a story as you move forward
- Peaceful Participation Features
  - Pavillion
    - A place of sheltered connection for gathering, dining, celebrating, relaxing
    - Modern structure that feels like an design-forward farmhouse patio
  - Lawn
  - Paved Walking Paths
    - Designed to allow for contemplative weaving around the perimeter of the park and in between the trees
    - Designed to gracefully lead visitors to meander from path, to swing, to grass, to learning and resting
    - A sort of labyrinth style meditative design paved with symbols, words, and stories stamped into concrete along the way
      - The shape and flow of the path would be designed in a way that it feels like the weaving of a Gullah Basket
  - Wind Chimes
    - Locally designed wooden windchimes that add to the serenity of the space
  - Garden
    - Vibrant, colorful native plantings with descriptive markers naming the plants and sharing stories of how various agricultural elements; flowers, plants, seeds, leaves, etc. were utilized for a variety of purposes
  - Bike Racks
    - Designed with engraved silhouettes of people fishing
  - Add interest to the cross walks and parking spaces with painted murals by local artists
  - A signature symbol in honor of the Indigo farming on the Island
