Provide a brief summary on the intended use of the grant and how the money would be used. (100 words or less)

STPHHI adheres to state guidelines to make sure that all stranded sea turtles are documented and sea turtle nests on HHI are marked, monitored, and measured for success. Our second mission is to educate visitors and residents concerning our most valuable natural resource and attraction, the beach, a nesting habitat for this endangered species. The impact of increasing tourism is evident with the increased effort that has gone into preserving the beach. We have found that our message,

"saving sea turtles" garners the attention and interest of visitors with environmental concerns, an emerging universal topic, allowing us to keep this impact manageable.

How does the organization/event either drive tourism to Hilton Head Island or enhance the visitor experience on Hilton Head Island? How is this impact being measured? (100 words or less)

With the past two grant cycles, STPHHI has made an exceptional effort to emphasize the importance of beach preservation. We have instituted a massive push on digital media (Video production, Facebook, Instagram, TikTok, Email newsletters, QR codes) and a hands on approach with increased turtle talks, events, and signage. Clicks and attendance have been documented to gauge visitor participation. STPHHI had also assisted the Chamber with NBC's Today Show episode resulting in 2,040,339 views, and The Bucket List Family influencers 1.41 million viewed. Multiple news interviews with local news channels, and magazines throughout the season are enumerated for this application.

How was the Number of Visitors/Tourists Documented? (250 words or less)

Volunteers log and track visitor counts at all educational events- (Physical 1-3) \*Based on the changes that we observed in 2022, we predict that our physical outreach will grow substantially in 2023. Our message has been distributed widely through digital outreach this season and we plan to create a facility in the future that will attract and accommodate tourists.

1. Zip Codes and number in party are collected. The free weekly public turtle talk at Celebration Park alone regularly attracted crowds of over 100 participants (approximately doubled from last season). The Westin, Sea Pines Resort, Marriott's Barony-Surfwatch-Grande Ocean, Ocean Oak, Omni, and Palmetto Dunes House/PD Cares also hosted weekly turtle talks for a total of 160 turtle talks at 9 locations, documenting 6,686 participants. \*65 individuals from Austria, Canada, England, Germany, Indonesia, Ireland, Italy, Netherlands, and Ukraine were identified

2. Weekly learning Kiosks are set up to educate visitors and collect their information if they are interested in learning more through our online presence at 3 locations - Shelter Cove Harborfest/fireworks, PD General Store, and Salty Dog South Beach for a total of 51 events during the season.

3. STPHHI prepared resident Turtle Trackers for the season's interaction with visitors with 17 training sessions at USCB in March and April with 350 participants. Other local events and civic organizations were served with sea turtle educational outreach for a total of 40 events {Ex. Crescendo, Daufuskie Island Conservancy, Earth Day Parris Island, Girl Scouts, Rotary, (Turtle Ambulance @Concours d'Elegance NOV), etc.}

4. QR codes on signage, placemats, flyers, and all of the beach vehicles digitally capture participant origin. A QR Code sticker was also produced and distributed to extend our reach. We reached 40 states with the QR Code initiative, resulting in 7,606 scans.

5. Marketing analysis of FB (641,897), instagram (44,328), and TikTok (42,227) reach is tracked- JAN - AUG 2022 totalling 728,452.

6. Website was redesigned and from JAN 2022 to present has hosted 13,116 unique visitors.

7. Newsletter open rate is tracked. 49,000 emails with a 58.7% open rate
8. WHHI online reach for our Talk of the Town, News, and Lowcountry Lowdown episodes is quantified. Results for Talk of the Town, Lowcountry Lowdown, our abbreviated video rotation, news cast, and ads totalled 1,293,164 impressions May - Sept 2022.
9. Chamber reach is guaged on the frequent inclusion of sea turtle patrol in their marketing effort through our Podcasts, NBCs Today Show, Bucket List Family Influencers, Website, and Social Media posts. We were featured in the annual HHI Vacation Planner (85,000 copies). HHI Sea Turtle "call out" recieved 5,396 clicks from the chamber website and provided 2,239 transfers to our website. Conde Nast Traveler featured HHI Sea Turtles in the September 2022 issue.
10. Media Coverage 2022: Island Packet (5), CH2 magazine (2), Local Life (1), HH Monthly (1), WJCL (2), WSAV (2), WTOC (1)
11. STPHHI "sand management" beach patrol attracts enumerable visitors with questions about the lifecycle and prosperity of our sea turtles. Volunteer staff perform "impromptu turtle talks" during patrol. Conservative estimates are around 200 individuals/day within 5 hour/14 miles to cover having contact with approximately \*36,000 visitors. *\*Not included in physical outreach numbers above*

## **B. DESCRIPTION OF OPERATIONS:**

Sea Turtle Patrol Hilton Head Island monitors Hilton Head Island beaches for sea turtle nesting and hatching activity annually, May through October, to promote the existence of these endangered species and to spread awareness of their struggle through public education and outreach. We are the exclusive permit holder for

SCDNR (South Carolina Department of Natural Resources) Marine Turtle Conservation Program on Hilton Head Island.

2. Describe in detail how the requested grant funding would be used? (250 words or less)

A marketing plan that was launched in 2021 has been redefined to incorporate the aspects that were the most robust for their quantifiable effectiveness. Based on the digital participation data and physical data collection, we were able to analyze the effort vs. result equation to realize that money spent on social media, digital media (Ex. video) emphasizing our message was highly beneficial to our cause - to protect our most valuable attraction and natural resource, the beach, for a successful sea turtle nesting season. As a result, our mission to protect endangered sea turtles is achieved. It is undeniable that sea turtles are a capable vehicle for "The Unofficial Mascot" on Hilton Head Island with the intent to rebrand for EcoTourism, a revival of the original concept. With National media coverage, Newsletter distribution, Turtle Talk participation, Social Media and QR Code analytics in 2022, we will be able to prove that we will carry this designation to a new level. We have expanded our reach in the community with learning kiosks, USCB training sessions that will be offered to locals as well as turtle trackers in 2023, a comprehensive Sea Turtle Friendly Hotel designation, WHHI TV segments, and continuation of the Turtle Trackers Volunteer Beach Ambassador Program. A community that is "all in" will encourage the visitors and tourists to act in accordance with ordinances and attitudes that protect our beautiful island and our ever increasingly important nesting habitat that hosted 423 nests in 2022.

3. What impact would partial funding have on the activities, if full funding were not received? What would the organization change to account for partial funding? (100 words or less)

Our organization performs nest monitoring for the Town of HHI, which is required for beach renourishment permitting from the state through a requirement called the Biological Review. Our performance is enhanced by the contribution of funding from ATAX to promote the welfare of sea turtles nesting on HHI. As a resort destination, the beach must be shared with the tourists as well as the sea turtles. We must inform the public to assist in the success of our reporting, and more importantly, the survival of an endangered species. Without ATAX funding, we would eliminate digital marketing/communication for education outreach.

4. What is expected economic impact and benefit to the Island's tourism?  
(100 words or less)

In today's digital world, we are able to quantify our reach. Until this past year, our organization did not take advantage of this resource. With ATAX funding, we were able to hire companies that could utilize our popularity to identify the opportunities that we could draw from based on our subject matter. It became evident that we could assume a significant role with EcoTourism for the benefit of the municipality as the largest nesting habitat, hosted by the most visited destination in Beaufort County. Together with the HHI Chamber of Commerce, Sea Turtles nesting on HHI have been Nationally recognized.

As previously mentioned, The HHI-Bluffton Chamber of Commerce has been a substantial partner for the promotion of sea turtle preservation. USCBHHI, Hotels participating in the Sea Turtle Friendly designation, and other Nonprofits, such as The Sandbox to host the Myrtle initiative, SC Aquarium Sea Turtle Care center to promote rehabilitation of stranded sea turtles, Outside Foundaton events collaboarative for beach preservation, and Island Rec Center to manage the facility for public turtle talks have assisted in elevating our mission. The Town of HHI and the SCDNR have benefitted from our success and have opened doors by promoting the passage of ordinances and upholding guidelines for the protection of endangered sea turtles. I also should mention the participation of

For-Profit businesses on the island, such as Coastal Provisions (SERG), Salty Dog, ITS Classics, Giuseppe's, and several realtors, among others that have been supportive.

7. Additional comments. (250 words or less)

Although our primary mission is to protect the biological sustainability of our nesting sea turtles, we realize that our success is mediated by engaging the tourists that frequent our beaches. We have no choice but to entice them to experience the wonder that we have the opportunity to offer. We have found that it is as much a draw for them as it is for us and we would like them to join us for a worthy cause, even returning annually to promote it!

\*Sea Turtle Patrol HHI (State and Federally permit holder) is the only entity that can provide up-to-date nesting and hatching information for hundreds of nests that spark the the interest of our beachgoers. We are also the only entity with access to the DNA histories of the female Loggerheads who have set flipper on HHI.

2. How were the ATAX funds used? To what extent were the objectives achieved? The ATAX Effectiveness Measurement spreadsheet available in the application portal will show the numerics. Use the space below for verbal comments. (200 words or less)

For the **DIGITAL** category, we contributed in excess as its success quickly proved to be the most effective. \$14,000 was budgeted, and \$16,600 has been committed to date. We feel that printed material promotes trash, when funds should be targeted for reusable materials.

**PRINT/OUTREACH** Of \$23,800, \$12,988.25 has been budgeted. We have found that much of this amount will be skewed to **OUTREACH** to include **RADIO/TV** category (total spent \$9,000) which proved to be effective with 1,293,164 views/\$9,000 spent. The expectation is to spend the total remaining funds, \$14,459 on **DIGITAL OUTREACH**

**SPECIAL PROJECTS and ONGOING EFFORTS (combined)** - Of \$10,100, \$3,852.22 has been committed. New props for turtle talks and AV supplies were purchased. Stickers will be restocked with addition of button (pins) to distribute to tourists. More video to appease the very FAQ "Where can we see a sea turtle nest hatching?" is planned with the option to convert into a 3-D experience, and a computer to store the data will be purchased.

3. What impact did this have on the success of the organization/event and how did it benefit the community? (200 words or less)

Below is an analysis, \$/head without considering the National Coverage, multiple printed articles, and interaction with STPHHI staff

on the beach. Ultimately, our message benefits the community by keeping up with due diligence for conservation of our island environment and endangered sea turtles nesting on our beaches.

The visibility of STPHHI has grown exponentially in the past two years. We have contributed to the Chamber of Commerce efforts greatly as well as appealing to current and potential visitors with our expanded digital media outreach. To date, our Facebook reach alone is 641,897. Our post synced with Instagram adds an additional 44,328 to that outreach, totalling 686,225 reached with 62,196 engagements among them. If we apply the conservative number of engagements to dollars granted in 2022, we average \$.77 cents with social media alone. TikTok is a new addition which will be included in future analysis.

Since January 2022, we have gained 6,358 new followers to our digital media accounts which is a 95% increase from 8 months.

\$.77 per individual does not account for the quantifiable physical outreach: Turtle Talks/Learning kiosks (6,656) and QR code (7,606) success that we have experienced. If applied as a whole, 76,423 engagements, or \$.63/person.

4. How does the organization measure the effectiveness of both the overall activity and of individual programs? (200 words or less)

While we measure our impact through visitor numbers from attendance programs such as our turtle talks, learning kiosks, and QR code interactions, we know that our impact spreads much further. Our e-newsletter maintained a high open rate of 58.7% and was sent to 49,000 emails. Our volunteers encounter over 100 beach-goers on the beach daily, totalling 18,000 visitors annually who see us picking up trash, filling holes, marking nests, assisting with hatching nests, and nesting turtles. This exposure to our mission and goals is not measurable by traditional means, but we see it in our engagement rates online, local press, public visibility, and in

the number of volunteers that we have recruited.




**RESOLUTION OF THE BOARD OF DIRECTORS OF THE SEA TURTLE PATROL HHI, 501c3**
