Provide a brief summary on the intended use of the grant and how the money would be used. (100 words or less)

\$50,000 will be used for tourist advertising.

\$13,593 will be used to offset expenses for our Learning Center facility that is located at 151 Gumtree Rd. and is available for tourist use. The \$13,593 represents 46% (our 2025 tourist percentage) of the budgeted amount of \$29,550. This budgeted amount does not include payments to the independent contractor who serves as our superintendent or equipment repairs.

How does the organization/project/event either drive tourism to Hilton Head Island or enhance the visitor experience on Hilton Head Island? How is this impact being measured? (100 words or less)

The chapter's driving range and Par 3 course provide visitor recreational opportunities year-round. It is a place for multi-generational play where families can enjoy time together learning, practicing or playing golf. The driving range and Par 3 golf course are open every day and are the only facilities of their kind open to the public, both locals and tourists in Beaufort County. Every guest is registered on our computer including their zip code to determine where they reside. Through August 31, 2025, our records show that 46% of our guests were from more than 50 miles away.

We have a registration terminal in our foyer where we register all visitors to the property. A staff member or volunteer inputs the number of kids and adults that are visiting, where they are from (based upon zip code), what amenity they want to use and how they heard about us.

B. DESCRIPTION OF OPERATIONS:

1. For state reporting purposes, give a brief description of the organization. (250 words or less)

First Tee – The Lowcountry is a youth development organization that blends golf with life skills and character education, ensuring that all children—regardless of background—have access to opportunities for growth. As part of the internationally recognized First Tee network, we share in a mission that since 1997 has introduced millions of young people to the values of honesty, respect, and perseverance through the game of golf.

Locally, our chapter was established in 2013 through a partnership between the Boys & Girls Club of Hilton Head Island and The First Tee. With the support of both public and private partners, a \$1.5 million capital campaign funded the creation of our Learning Center, a 13-acre campus featuring a driving range, 8,500-square-foot putting green, and 6-hole par-3 course. Since opening in 2016, this facility has become a hub for learning, mentorship, and community engagement.

Our programs reach children across Beaufort and Jasper counties through classes, camps, and the First Tee School Program, which integrates our curriculum into physical education classes. This year alone, more than 14,000 young people will be positively impacted by our work—building confidence, resilience, and character that extend well beyond the golf course.

At First Tee – The Lowcountry, golf is the vehicle, but character is the outcome. By combining a safe, welcoming environment with caring adult mentors, we equip the next generation to make healthy choices, achieve their goals, and give back to their communities.

2. Describe in detail how the requested grant funding would be used? (250 words or less)

The Town of Hilton Head Island ATAX grant funds will be used for tourist-based marketing programs and to help defray the cost of maintaining our Learning Center.

We have seen a substantial increase in the number of out-of-town visitors to our property again in 2025, largely due to the effective use of the funding we received from the 2025 ATAX grant. By the end of this year, we are projecting the total number of visitors to the property will exceed 9,500 guests, an increase of 8% from 2024.

Successful marketing vehicles that we have used this year and would continue to use include print advertising, direct mail campaigns, email blasts and Facebook ads, brochures, rack cards, newsletters and TV and radio spots.

The increased use of the facility creates a greater impact each year on the maintenance of the Learning Center. We are requesting an additional \$13,593 for 2026. This represents 41% (our 2025 tourist rate) of our annual budget of \$29,550 for maintaining the facility. This budgeted amount **does not** include payments to the independent contractor that serves as the superintendent of the facility and equipment repairs.

We have always viewed our relationship with the ATAX program as a partnership. We have never requested to fully fund any part of our operations and continue to do so for 2026.

As noted earlier in this application the total cost for advertising and maintenance is \$109,550 we are requesting a total of \$63,593.

3. What impact would partial funding have on the activities, if full funding were not received? What would the organization change to account for partial funding? (100 words or less)

Accommodation Tax funds will be used to expand marketing efforts that attract visitors and maintain the high-quality conditions of the First Tee – The Lowcountry Learning Center, recognized as the area's premier public practice facility. These funds will allow us to continue increasing awareness among both visitors and locals, sustaining the 8% growth in overall use achieved in 2025. To ensure strong operations, our organization will commit \$45,957 from our general revenue for facility upkeep and advertising. ATAX support is critical to sustaining visitor growth and protecting the facility's reputation for excellence. Advertising and maintenance are so intertwined that a reduction in one portends to a reduction in the other.

4. What is expected economic impact and benefit to the Island's tourism? (100 words or less)

Vacationers look for unique, family-friendly experiences when choosing destinations, and our targeted outreach continues to attract new visitors. As of August 31, 2025, 7,099 tourists, 46.1% from more than 50 miles away, visited our facility, compared to 43.1% during the same period in 2024, a 3% increase. Our on-site registration terminal, staffed by employees or volunteers, records each visitor's information, including number of adults and children, home zip code, chosen amenity, and how they heard about us. This system provides accurate data to measure impact, track growth, and guide future marketing strategies that strengthen our role as a tourism destination.

Collaboration is at the heart of First Tee – The Lowcountry’s success. From our co-marketing agreement with the Hilton Head Island Rec Center to our long-standing partnership with the Boys & Girls Club of Hilton Head Island, we work hand-in-hand with community organizations to expand access and awareness. The PGA TOUR Superstore in Bluffton also promotes our programs, demonstrating how local and national partners help amplify our reach.

Our Learning Center is one-of-a-kind: the only public Par-3 course on Hilton Head Island. With a family-friendly donation of just \$30 for all-day use of every amenity, it offers unmatched value for visitors. These collaborations, paired with a unique and affordable facility, ensure that families, tourists, and local youth alike benefit from a welcoming space that blends golf, character education, and community engagement. Our guiding philosophy—“Teams Win”—reflects the partnerships that sustain us, including support from The First Tee National, Boys & Girls Club, PGA TOUR, PGA of America, USGA, LPGA Girls Golf, Professional Golfers Career College, and 24 local schools. Together, we are building stronger kids and a stronger community.

First Tee – The Lowcountry is funded through a diverse mix of revenue streams that ensure both stability and community investment. Primary support comes from individual donors, corporate sponsors, private foundations, charitable trusts and government grants. Additional income is generated through program fees, special events, and modest facility-use donations, ensuring affordability for all families. This broad base of funding sustains our operations, maintains our facility, and provides scholarships so no child is turned away.

2. How were the ATAX funds used? To what extent were the objectives achieved? The ATAX Effectiveness Measurement spreadsheet available in the application portal will show the numerics. Use the space below for verbal comments. (200 words or less)

In 2025, ATAX funds were used to expand marketing and promotional efforts for the First Tee – The Lowcountry Learning Center, including our driving range and Par-3 golf course. Funds supported advertising in Island Events Magazine and The Golf Guide, the production of postcards, rack cards, and handouts, as well as targeted social media initiatives. These included website enhancements showcasing amenities and programs, Facebook banner ads, and quarterly newsletters—all designed to reach both visitors and locals.

The impact of these efforts is clear. Visitor numbers have grown significantly, with 7,099 guests recorded through August 31, 2025, compared to 7,570 for all of 2024. We project an additional 2,500 guests by year-end, resulting in an estimated 9,500 total visitors—an 8% increase over 2024. Notably, 46% of visitors come from more than 50 miles away,

demonstrating that ATAX-funded outreach is successfully attracting tourists and enhancing Hilton Head Island's reputation as a family-friendly destination.

By strategically investing ATAX funds into consistent, high-quality marketing, we have not only achieved but exceeded our objectives: raising awareness of our unique public facility, increasing visitation, and supporting the Island's broader tourism economy.

3. What impact did this have on the success of the organization/event and how did it benefit the community? (200 words or less)

ATAX funding directly strengthened the success of First Tee – The Lowcountry by expanding outreach and attracting more visitors to our Learning Center. With enhanced advertising, social media campaigns, and printed materials, awareness of our amenities grew significantly. Total visitor traffic through year-end in 2024 was 7,570 in 2024. Through August of 2025 we have had 7,099 with projections of 9,500 total by year-end—an 8% increase. Importantly, 46% of these visitors in 2025 traveled from more than 50 miles away, a 3% increase, confirming the facility's value as a tourism destination.

This growth benefits both our organization and the wider community. Increased visitation sustains program revenue, helping us provide scholarships so all children—regardless of background—can participate in our youth development programs. At the same time, tourists drawn to our facility contribute to the local economy through lodging, dining, and retail spending. The facility also provides affordable family recreation, with a full day's access for just \$30, ensuring Hilton Head remains welcoming to families of all income levels.

In short, ATAX funding elevated awareness, expanded access, and delivered lasting benefits to both youth and the community.

4. How does the organization measure the effectiveness of both the overall activity and of individual programs? (200 words or less)

We measure our success by the increase in the number of visitors that use the property and by the number of kids that attend our programs. We gather this information as visitors register on a computer in our reception area and kids register for our programs on our website.

Visitors are projected to increase from 7,570 in 2024 to 9,500 in 2025.

Our percentage of patrons that are tourists has increased from 43.1% in 2024 to 46.1% in 2025.

Kids in The First Tee Programs at golf facilities are projected to increase from 573 in 2024 to @625 in 2025.

We have added three more schools to the existing 23 in the First Tee Schol program in 2025 bringing the total to 26.

AUGUST 19, 2025 - Board Meeting Minutes

- The August meeting of the First Tee of The Lowcountry Board of Directors was held on August 19, at the First Tee Offices, 23 Plantation Park Drive, Bluffton, SC. Meeting was called to order at 2:05 PM by Chair Gaines.
 - Attendance:
 - Directors Present: Chair Paul Gaines, Krista Dunton, Lynn King, Jackie Lambe, Chris Lane, Brad Taylor, Ed Tiscornia
 - Directors Not Present: Paul Rothwell, Grace Chu, Bill Fuge
 - Directors Present via Zoom – Joe Datillo, John Farrell, Chuck Wiseman
 - Staff present: Pat Zuk (Zoom), Aaron Immel, Ryan Wolfe
- The Minutes of the May meeting were reviewed. After a discussion regarding the financial audit still not signed off as of this meeting, a motion to approve the minutes was made by Krista Dunton, seconded by Brad Taylor, and approved.
- **Introduction of Special Guest**

Paul Gaines introduced Bob Risk as a candidate interested in joining the FTLC Board. Bob shared his personal connection with the First Tee as he set up a scholarship fund in memory of a dear friend. After introductions, Lynn King made a motion to accept Bob Risk as a new board member, second was made by Chris Lane and motion was unanimously approved. An electronic vote will confirm his appointment.
- **Reports**
 - **4.1 Treasurer's Report – Jackie Lambe**
 - Jackie Lambe and Ed Tiscornia discussed three CDs that were coming due in September and wanted Board direction regarding next steps. Also, the Board was reminded there was a balance of \$390,000 at Coastal States Bank and it was decided that money needed to be moved into the Fidelity money market.
 - Ed made a motion for
 1. #1 CD totaling less than \$320K to rollover for two years.
 2. #2 CD capital reserve around \$140K to rollover for two years
 3. CD #3 for about \$42K (scholarship account) to rollover for 1 yr.

Chris Lane seconded the motion, approved.
 - **4.2 Executive Director Report – Zuk**
 - Facility usage through July was up, as was tourist usage.
 - Reviewed several ongoing projects at facility.
 - Donor Update – 217 total donors to date for 2025

- ATAX application is being drafted by Pat, and the Board discussed its support. Jackie Lambe made a motion to approve the 2026 ATAX application as discussed, Chuck Wiseman seconded the motion and Board unanimously approved.

Discussed Schwab Challenge Grant Update projected 2026 requirements:

1. Total Donors needed: 557 (balance needed 217)
 2. Total Dollars needed: \$643,700 (have \$506,251) – need \$137,449.
- Pat mentioned Safe Sport/Background Checks and there are still a couple of board members that need to complete.
 - John Farrell brought up a new program **First Tee Tuesdays** – hosted by Sea Pines Resort at one of the Plantation courses – which will be free lessons given by local golf professionals. Farrell is recruiting Sea Pines Pros, and other Island/Bluffton pros to be available to give “free” half hour lessons on Tuesdays. The program will be online registration and free of charge. Pat/John will put together the plan, start date and circulate to the Board as it comes together.
- **4.3 Program Director's Report – Immel**
 - Reported it was a good summer across all programs; four of eight camps were filled.
 - FTLC has had up to 350 participants so far in 2025 through the summer session.
 - Immel shared a new Boys & Girls Club/Bluffton pilot program at Pinecrest for 10–12-year-olds. Mid-September is the target date for kickoff.
 - Ryan shared FTLC kids are going to Pawleys Island to participate in a SCJGA All Star Tournament; Paul Gaines asked for some marketing coverage.
 - Ryan discussed the Tour Card induction program – currently have 27 (goal is 50)
 - Suggestion was made to have a Tour Challenge for players to work towards making; John Farrell offered the support of Sea Pines/Harbour Town Golf Links in December as a season ending championship.
 - Krista Dunton discussed the FTLC girls/LPGA Golf Program – more to come.
 - **4.4 Development Specialist's Report – Pat Zuk (for Cari Schmidt)**
 - Key focus for remainder of 2025 – highlight students, celebrate donors, support the Golf Tournament, promote HHI facility and FTLC programs.
