  - Dimensioned floor plans
  - Site plan must show existing and proposed structures, lot acreage, impervious/pervious coverage and setbacks and buffers.
  - Plans of all electrical (to include electrical load calculations), mechanical and plumbing work.
  - Structural plans showing at a minimum, foundations, wall sections and loads (including calculations)
  - A South Carolina Engineer seal
  - An Architect's seal IF the building is a commercial building that is:
    - Over two stories OR
    - Over 5,000 square feet OR
    - If the building is an Assembly Building, Institutional Building, Educational Building or Hazardous Building.
  - Elevations (including ground floor, 1<sup>st</sup> floor and equipment) must be in NAVD 88 Datum
  - Show the height of the roof or highest roof feature in NAVD 88 Datum
  - Show the required setback angles, if applicable
  - Tree protection fencing and silt fence should be delineated and labeled along the edge of all required buffers
  - Construction exit must be labeled
  - Label the OCRM critical line, the Town's Beachfront Line, Transition Area and Coastal Protection Area where applicable
- Mechanical Certificates
  - Gas
  - Plumbing
  - Mechanical/HVAC
  - Electrical
